### **Apply online:**

The online application is the preferred application method. To apply online, go to **www.usf.edu**. Click “Apply - Undergraduate” and follow directions. The non-refundable application fee for applying online is \$30.

### **Apply by mail:**

Complete each item. An incomplete application may delay the processing of your application.

Complete the Florida Residency Statement attached to the application.

Return your application to the address above. You will receive an email notification once your application had been received and instructed on how to submit the \$30 payment by using a credit card, debit card, or e-check – **do not mail in a check or cash.**

A Florida resident for tuition purposes is a person who has, or a dependent person whose parent or legal guardian has, established and maintained legal residency in Florida for at least twelve months. Residence in Florida must be as a bona fide domicile rather than for the purpose of maintaining a residence incident to enrollment at an institution of higher education. To qualify as a Florida resident for residency classification purposes, a student's residence requirement may be classified as Florida residents for tuition purposes only if they fall within one of the limited special categories, authorized by the Florida Legislature and Board of Regents. All other persons are ineligible for classification as a Florida resident for tuition purposes. Living in or attending school in Florida will not, in itself, establish legal residence. Students who depend on out-of-state parents for support are presumed to be legal residents of the same state as their parents.
