 - 17 Davis and Health Park
 - Tampa Crossroads
 - Athletic Medicine
 - James A. Haley VA Mental Health Department
- Complete the training requirements, including workshops, evaluations, client tracking logs, and supervised clinical hours.
- Complete and submit all required information necessary for accurate reporting and project documentation for HRSA.
- Continue career path and seek employment working with underserved population post graduation.
- Respond to requests post graduation for information necessary for program reporting for

BHWEIUSF scholars receive a one-year training in the principles and best practices of integrated behavioral Health (IBH) by completing didactic workshops and fieldwork experiences.

Stipends are available through a federal grant from Health Resources & Services Administration (HRSA), United States Department of Health.

The NBCC Foundation will administer 30 to master's-level counseling fellowships of \$10,000, plus the travel expenses to participate in program related trainings for mental health counseling students.
